A hearing on the Debtors’ Revised Disclosure Statement pursuant to section 1125 of the Bankruptcy Code, will commence on April 3, 2008 at 2:30 p.m. prevailing Eastern Time, before the Honorable Kevin J. Carey, United States Bankruptcy Judge, located at 824 Market Street, 5th Floor, Courtroom No. 4, Wilmington, Delaware 19801 (the “Revised Disclosure Statement Hearing”). The Bankruptcy Court will only consider written objections filed and served by the Objection Deadline that state with particularity the grounds for such objection.
