PLEASE TAKE NOTICE that an order (the "Confirmation Order") of the Honorable Christopher S. Sontchi, United States Bankruptcy Judge, approving the disclosure statement, solicitation of votes and voting procedures and forms of ballots, and confirming the above-captioned debtors' (collectively, the "Debtors") *Second Amended Prepackaged Joint Plan of Reorganization Pursuant to Chapter 11 of the United States Bankruptcy Code (With Technical Amedments)*, dated October 10, 2008 [Docket No. 164] (as amended and supplemented, the "Prepackaged Plan"), was entered by the United States Bankruptcy Court for the District of Delaware (the "Bankruptcy Court") on October 14, 2008 [Docket No. 191]. Unless otherwise defined in this notice, capitalized terms used herein shall have the meanings ascribed to them in the Prepackaged Plan and the Confirmation Order.

PLEASE TAKE FURTHER NOTICE that the Confirmation Order is available for inspection during regular business hours in the office of the Clerk of the Bankruptcy Court, 824 Market Street, 3rd Floor, Wilmington, Delaware 19801. Please note that a PACER password and login are required to access documents on the Bankruptcy Court's web site.
